 - ii. The promoter shall deposit seventy percent of the amounts realised by the promoter in a separate account to be maintained in a schedule bank to cover the cost of construction and the land cost to be used only for that purpose as per sub-clause (D) of clause (1) of sub-section (2) of section 4;
 - iii. The registration shall be extended by a period of **5 months, 2 weeks and 2 days** and shall be valid until **12/04/2026**
 - iv. The promoter shall comply with the provisions of the Act and the rules and regulations made there under;
 - v. The promoter shall not contravene the provisions of any other law for the time being in force as applicable to the project;
 - vi. If the above mentioned conditions are not fulfilled by the promoter, the Authority may take necessary action against the promoter including revoking the registration granted herein, as per the Act and the rules and regulations made there under.
 - vii. The Promoter shall protect the rights and interests of the Allottees and to follow the AOS conditions.
 - viii. The Promoter shall be required to file/upload upto date QPR's and Form -7.
 - ix. The Promoter shall be required to submit revised Form- B, indicating revised date of completion of the Project.
 - x. The grant of extension of the project validity shall not affect/jeopardize the rights accrued in favour of the allottees who have booked their plot, or unit or apartment or building or villa in the said real estate project as the case may be for which extensions of project validity is sought.
